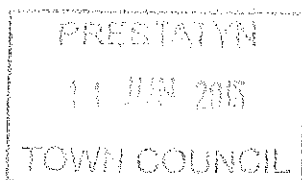

To whom it may concern,

Following the success of our involvement in Prestatyn Rocks 2014, I propose that Stages for Events could take on the responsibility of organising the whole music festival to create a sustainable, commercial event in Prestatyn for many years to come. I will continue to keep a similar theme and also free admission and I will invite local shops and businesses to put up stalls etc to help get the community involved. My intention is to put the event on at Prestatyn events field on bastion rd, which given that the Nova is no longer operational, should also help bring custom to that part of the area and satisfy local businesses such as the mini golf etc.

As well as being a stage hire company, Stages for Events has acquired lots of experience in event management, hosting events such as Woodfest, Prestatyn Rocks, Castell Beat and Rhuddfest. This has provided the opportunity for me to work with Denbighshires licencing process with regards to events. This includes working alongside Denbighshires tourism marketing and coastal events manager, Vicki Shenton, and also PCSO 2718 Suzanne Wilson, to develop a good working relationship with the local police. As always I am very conscious of ensuring our events are kept to the highest standard with regards to health and safety and will carry out all necessary and appropriate risk assessments.

A small financial contribution may be necessary for Prestatyn Rocks 2015 and possibly 2016. As I'm sure the town council are aware, the costs of putting on the festival are fairly substantial. My intention is to make the event sustainable enough to cover its own costs within two years. The stage hire cost alone is in the region of £1900, therefore I have attached a copy of the Town Events Grant application to aid our efforts.

Proposed intention to begin a Table tennis section of our club in Prestatyn, so as to encourage young people ages 7-18yrs old and adults, to participate locally in our club. The Club Coach, Barrie Russ, has full DBS certificates and Licence and Insurance documents for this purpose.

We are looking for a venues which is not too expensive, in which we can start this club and then develop its potential in a similar way to our club in Rhyl.

We have recently won the Gemau Cymru Table Tennis event run in Cardiff and results can be seen on our governing body's website, ttaw.co.uk in conjunction with other players from Flint and Wrexham, Barrie Russ being the overall Coach of the team from North Wales.

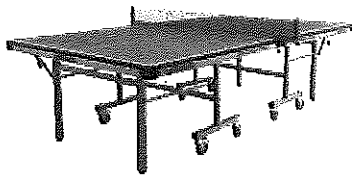

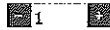

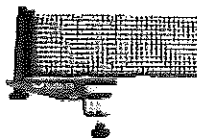
