1 WELCOME AND HOUSEKEEPING

Cllr A. West, Mayor and Locum Town Clerk welcomed all those in attendance and provided details of housekeeping and emergency procedures.

2 MAYORAL COMMUNITY ACHIEVEMENT AWARDS 2024/2025

Cllr A West, Mayor expressed his great pleasure on hearing about the significant contributions being made to the Town and local community by many volunteers and nominated persons this year. The Mayoral Community Achievement Award Winners 2025/26: -

Natalie Lewis (Lead Student-PHS) - Eco Club Students, Prestatyn High School have created a Community Eco Garden encouraging young people and students to get involved with the project. Natalie also helps the Marine Conservation Society to protect sea and shorelines.
