This includes electors or their proxies who wish to make alterations to their existing arrangements on a permanent basis.
6. Applications to appoint a proxy at this election must reach the Electoral Registration Office, Room 235, County Hall, Ruthin, Denbighshire, LL15 1YN by **5 pm on Wednesday, 8th July 2015**.
7. Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5 pm on Wednesday, 8th July 2015, must reach the Electoral Registration Office, Room 235, County Hall, Ruthin, Denbighshire, LL15 1YN by **5 pm on Thursday, 16th July 2015**.
8. Applications to be added to the Register of Electors in order to vote at this election must reach the Electoral Registration Office, Room 235, County Hall, Ruthin, Denbighshire, LL15 1YN by **Wednesday 8 July 2015**.
